BOARD OF EDUCATION REORGANIZATION MEETING

CENTER MORICHES, NY JULY 10, 2019

The Board of Education, Center Moriches Union Free School District, held the Reorganization Meeting in the Board Room on Wednesday, July 10, 2019 at 7:30 p.m. Those present were Board Members Danielle Dench, Joshua Foster, George Maxwell and Board Members elect Marcus Babzien and Thomas Kelly, Superintendent Ronald Masera, Assistant Superintendent Ricardo Soto, Assistant Superintendent for Business Keri Loughlin, District Treasurer Diane M. Smith and District Clerk Patricia A. Galietta.

Temporary Chairperson Patricia A. Galietta called the Reorganization Meeting to order at 7:45 p.m. with the Pledge of Allegiance. There were 20 visitors present.

1. Administration of Oath/Election of Officers
