# BOARD OF EDUCATION REGULAR MEETING VIA ZOOM

The Board of Education, Center Moriches Union Free School District, held a Virtual Regular Meeting on Wednesday, June 17, 2020 at 5:30 p.m. Those participating were Board Members George Maxwell, Danielle Dench, Marcus Babzien, and Thomas Kelly; Superintendent Ronald Masera, Assistant Superintendent Raina Ingoglia, and Assistant Superintendent Keri Loughlin. Mr. Foster joined the meeting at 7:00 p.m. and District Clerk Patricia A. Galietta joined the meeting at 7:28 p.m.

On motion by Mrs. Dench, seconded by Mr. Kelly and carried 4-0, the Board voted to enter into Executive Session at 5:35 p.m. for the purpose of contract review.
